### TERMS AND CONDITIONS

# Buyer has paid a deposit of \$\_\_\_\_\_\_, with payment of the balance of \$\_\_\_\_\_\_ due upon release of the Dog to Buyer. The expected pickup date is \_\_\_\_\_\_, or such other date as the parties may mutually agree. Payment of the balance must be made by cash or money order. Buyer acknowledges and agrees that Buyer will forfeit the deposit and any rights to the Dog if: a) Buyer fails to complete the purchase of the Dog for any reason. In the event that the Dog is not available due to sickness, death, or any other circumstance owing to the fault of Seller, Buyer's deposit will be either (i) refunded, (ii) transferred to another puppy from currently litter, if available, or (iii) transferred to the next little of puppies. A boarding fee of \$\_\_\_\_\_\_ per day will be charged for each day the Dog is boarded by Seller past the

agreed pickup date.

Upon payment in full of the Purchase Price, Seller (at Seller's sole cost) shall promptly take all actions required to officially transfer ownership and registration (if any) of the Dog to Buyer.

Seller agrees that the Dog is up to date on immunizations and deworming. The Dog has no known disease or life-threatening congenital defects at the time of pickup.

Should two unassociated veterinarians diagnose the Dog with a disease or life-threatening congenital defect, Buyer must provide a written statement form both veterinarians, including the vet's name, address, and business phone number. Seller will pay 50% of actual and documented vet costs- up to \$200. In the event the Dog dies, Buyer may choose another puppy of equal purchase price when availability allows.

The Dog will never be relinquished to an animal shelter. If, during the Dog's life, Buyer cannot or does not wish to maintain proper care of the Dog, Seller must be contacted to discuss alternative placement. If a suitable home cannot be found for the Dog, Seller will take ownership again, and care for the Dog.

## 3. Seller's Representations and Warranties

Seller represents and warrants to Buyer that:

- a) Seller is the legal and true owner of the Dog and that Seller has full right and authority to sell the Dog.
- b) The Dog is being sold free and clear of any lien, security interest, charge or other encumbrance.
- c) Seller guarantees that the Dog is a purebred dog, offspring of the purebred sire and purebred dam set out on page 1 of this Agreement.
- d) Buyer agrees to not use this animal for breeding. \*Applicable when any selection other than Breeding for the "Purpose of Dog" is chosen.
